On April 24, Lacasa's Board of Directors announced their appointment of Chris Kingsley as the successor to Larry Gautsche as Lacasa's President/CEO. This was the result of a nationwide search conducted over late 2017 and early 2018. Chris has been with Lacasa for seven years, working for the first five to spearhead creation and delivery of financial empowerment services and for the past two as the Vice President of Development. Chris assumes the president responsibilities starting on August 6th.

"One component of the board's search process was seeking input from a wide variety of stakeholders across the county," states Lacasa Board Chair Nathan Mateer Rempel. "We asked what qualities were needed in leadership for Lacasa going forward, and how Lacasa could support our community. Chris' strengths align beautifully with what we heard from the community and we look forward to working with Chris in bringing Lacasa to a new level of service in Elkhart County."

Looking Back: Celebrating 17 Great Years



Serving as Lacasa's president for the past 17 years has been an adventure and a real honor. Despite the challenges, Lacasa has continued to mature as an organization, significantly expand the scope and impact of services, extend opportunity to thousands of families, and make a noticeable impact in many neighborhoods.
